Dear Parent / Carer

I trust this finds you well as we begin our summer term and trust that you had a good Easter holiday. I would like to provide some important updates and reminders which I would urge you to read carefully and share with your child.

Uniform Expectations:

I would like to remind all parents, carers and students that the uniform is the most basic expectation of school life and we expect that all students will be able to comply with our uniform guidelines which have been designed to be as straightforward and affordable as possible at this time. Over the last term the standard of uniform has improved dramatically in school and we need this to continue in the summer term. Details of our uniform policy can be found here: https://gps.hslt.academy/uniform Students who arrive at school wearing incorrect uniform will be given the opportunity to correct the issue immediately; those who are not prepared to correct the issue will be sanctioned. Can I please remind all parents / carers of three specific issues that regularly occur:

- Only plain black shoes, trainers or boots are acceptable and no coloured logos or branding should be visible on trainers, shoes or boots.
- The only permitted jewellery is one pair of stud earrings; all other piercings must be replaced with clear plastic retainers during the school day.
- False eyelashes are **not** permitted; any students who arrive at school wearing false eyelashes will be expected to remove them immediately.

We have a stock of uniform in school for students who have forgotten an item which is washed after use; however some items of uniform have not been returned to school meaning that these stocks have now dwindled. Please can I ask all parents / carers to check with their child to see if they have any uniform items which belong to school and return these to school as soon as possible? Thank you for your support in ensuring that we can lend items to students who have genuinely forgotten an item on a daily basis.

Behaviour Expectations:

Year in the first instance.

Thank you for your feedback regarding the revised localised behaviour procedures in school. The learning environment in school has visibly improved and the procedures allow students opportunities to correct their behaviour with no sanctions through the verbal warning and phase one warning system. We are aware that families wish to know more about reasons for phase two and phase three sanctions and a new 'menu' has been made visible to families on Edulink which will show a reason for a sanction wherever possible. We appreciate your support in discussing incidents with your children and helping them reflect on behaviour choices. Where behaviour unfortunately leads to a period of time in the reflection room in phase four, we appreciate your support in reminding your child that they need to attend this room and complete their sanction. May I remind you that our basic expectation for students is that they have a black/blue pen, a green pen, a pencil, a ruler and a calculator with them every day. Parking At School:

Please be mindful when collecting your child for school that cars must not park on the double yellow lines at the front of school. The road outside school is extremely busy at the end of the school day with buses, taxis, cars and pedestrians all trying to share spaces and we would appreciate your support in keeping this space as safe as possible.
